WHERE ARE WE

Brief recap of where we are in the PlanET process by Mark Donaldson.

CONCEPT EVOLUTION

Review by Tim Kuhn of how we got from the chip maps to conceptual maps seen today.

PlanET INTERACTIVE EXERCISE

Mark Donaldson facilitated a modified Meeting in a Box Metroquest activity and asked for feedback from the WG members.

Feedback notes:

- What are we saying when we select traffic congestion?
Response: On one of those should read want to minimize.
- Some of the indicators have relationships to others.

PRIORITIES & CONCEPTS ANALYSIS

Kevin Tilbury, GS&P, led the WG members through a more detailed discussion of the concepts and priorities.

Additional feedback notes:

- Question on slide Priority Housing Diversity Index – What are these numbers? Kevin explained that it is a ratio, not raw numbers, stating that they don't have access to information to get raw numbers.
- Question regarding ¼ mile distance...Is that as a crow flies? Response, yes.
- Cities – are we using city limits? Response, yes.
- Water quality on cities and towns...Why is that negative? Looking at existing and future impervious surface next to impaired streams and the impaired streams are in cities and towns.
- Intensification impacts impervious surface impacts, redevelopment cannot be worse from the stormwater impacts, impact of added stormwater regulations in urban area shift where developing in greenfields outside the urban area are easier and cheaper.

NEXT STEPS & CLOSING

Mark Donaldson discussed what is next in the PlanET process and what we need from each WG in terms of participation and input over the next 3 -4 months. Working Group members will be asked to meet 4-5 times between now and the fall.
